These relationships are created with a goal to provide children with the emotional and social support, attention, and guidance necessary to support strong scholastic achievement, healthy peer-to-peer/family relationships, avoidance of risky behaviors, and strong self-concept.

Among children served, ages range from seven (7) into young adulthood (18-21). Further, children served will often live in poverty; (see Sch. O)

The success of BBBSL's mission-fulfillment depends on the time and talent of community volunteers serving as mentors, board members, and committee members. The BBBSL Board of Directors meets every other month for two (2) hours with rare ad hoc board meetings convened as necessary. Additionally, most of our board members are actively fundraising and recruitment mentors where they will serve roughly four (4) additional hours with our organization each month. Additionally, roughly 30% our board serves on a board-level committee, where they dedicated 1-1.5 additional hours of service every other month. We estimate that our board members collectively dedicated no less than 800 hours each year to advancing our mission or roughly five (5) hours each month.

Our critical force of volunteer mentors, known as "Bigs," dedicate five hours of time even before becoming a mentor for a comprehensive interview, paperwork completion, and volunteer training. Once "matched" with their "Little," Bigs then commit to spending no fewer than four hours a month with their mentee. Most, however, end up spending six to eight hours together with their Little each month. With an average of 126 active mentors each month for the year (and service to 175 matches cumulative for the year), it is reasonable to estimate that our mentors dedicated 9,012-12,096 hours of time to their Littles in fiscal year 2020-2021. In light of the COVID-19 pandemic, BBBSL issued several rounds of Safe In-Person Match Policy, and resumed match-making in September 2020. Currently, our matches are meeting safely in-person and we are growing again.

childhood experiences including, but not limited to physical and/or sexual abuse; physical and/or emotional neglect; domestic violence; substance abuse within the household; household mental illness; parental separation or divorce.

EVEN facing such significant system obstacles, ALL the Littles BBBSL serves are chock full of potential, talent, and resilience and deserve the opportunity to chase down their BIGGEST dreams. We say "YES" to hopeful parents and guardians who see incredible potential in their child and we commit to finding a safe and caring adult mentor/Big willing to stand in their mentee's/Little's corner and have their back.

As such, BBBSL's model is designed to help youth gain protective factors that help prevent and build resiliency against additional childhood adversity and to help children imagine healthy, happy, and productive futures. To ensure effectiveness, BBBSL measures and tracks the social, emotional, and academic progress made by each Little using an evidence-based youth and child outcome surveys at regular intervals. Staff compares pre- and post-survey results to assess child improvement in key areas. Professional staff use outcome data 1) to help inform coaching provided to mentors and parents/guardians to support future improvement and 2) to improve overall case management support provided to parents and mentors. Outcomes surveys measure changes in parental trust, social acceptance and peer relations, scholastic improvement; educational expectations; exposure to risk behaviors. Over time, all such factors correlate with improved school attendance, classroom behavior, grades, and graduation; improved mental health and self-esteem; avoidance of substance abuse and crime.

Also acknowledging that longer, stronger relationships result in the most positive outcomes for children, BBBSL also conducts a relationship assessment designed to evaluate the strength of mentor-child relationships with a goal of increasing match retention. Staff review all outcomes assessments and conduct continuous quality improvement in BBBSL's service delivery and to inform coaching provided to mentors and parents/guardians. Further, staff adapts child case plans to address persistent concerns or meet new emerging needs. Thanks to this rigor, BBBSL's average match length after 12-months in the program is greater than 36 months.

Parents/guardians wishing for their child to receive one-to-one mentoring refer their child into the BBBSL's program. Following referral, BBBSL interviews both the child and the parent/guardian to identify whether the child and family would benefit from and be able to support a child-adult mentoring relationship. Additionally, the interview seeks to understand each child's social/behavioral/academic goals/needs, each child's interests/preferences, and the parent's/guardian's preferences for the mentoring relationship. Should BBBSL deem itself able to secure a volunteer mentor for the child it will enroll the child into the program. BBBSL does not charge families to participate in the program.

Volunteers who are interested in becoming a Big Brother or Big Sister must also go through an assessment/enrollment process which includes a comprehensive interview, criminal and driving background checks; reference checks, orientation, as well as initial, and when necessary, ongoing training to include, but not be limited to, child safety, trauma, cultural awareness, etc. Child safety is at the heart of the program, so before

being matched, volunteers are screened both to determine whether they will be appropriate mentors. Further, the mentor's interview will seek to determine the mentor's preferences, interests, and unique experiences that could prove beneficial for the mentoring relationship. BBBSL requests that volunteers cover the costs of their background checks.

When matching a child with an adult mentor, staff carefully consider all factors (interests, experience, geography, etc.) to make the best match possible. Once a match is made, the adult mentors provides their Little Brother or Little Sister with individualized attention two to four times each month (four to eight hours total) for at least one year. During regular, unstructured outings, mentoring pairs have the freedom to choose the activities they will enjoy and from which the child will benefit most. With parent/guardian approval, these activities can take place wherever they decide in the local community as the mentoring pair builds a strong, lasting friendship. BBBSL provides suggestions about a range of low-cost or free activities to participate in and around the local area and invites matches to quarterly agency-hosted activities. During time with their mentors, children expand their experiences beyond their families or neighborhoods, gain new skills, explore new interests, and talk with an adult they trust one-on-one.

To ensure the mentoring relationship is progressing safely, that children are benefiting measurably from their mentoring relationship, that mentors are receiving the support they need to stay committed, and that there is consistent communication between everyone involved, BBBSL requires monthly (first 12 months) or quarterly (following 12 months) support phone calls

Match support calls take place 1) between the staff and the mentor, 2) between the staff and the parent/guardian, and 3) between the staff and the child. Additionally, mentors and families are encouraged to reach out to staff anytime they feel they need additional support or referrals to other community partners.
